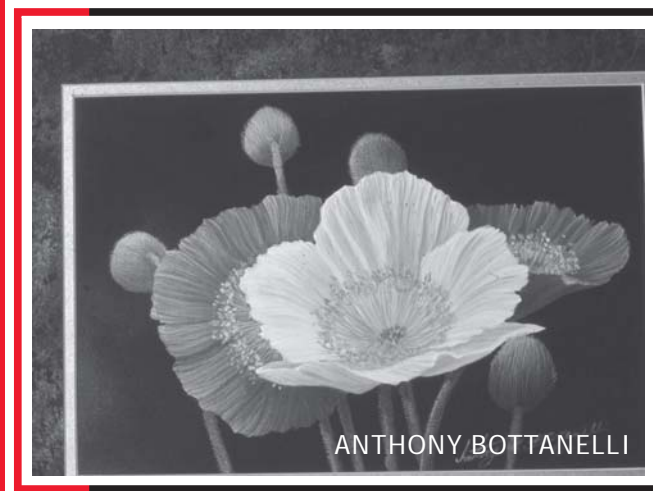

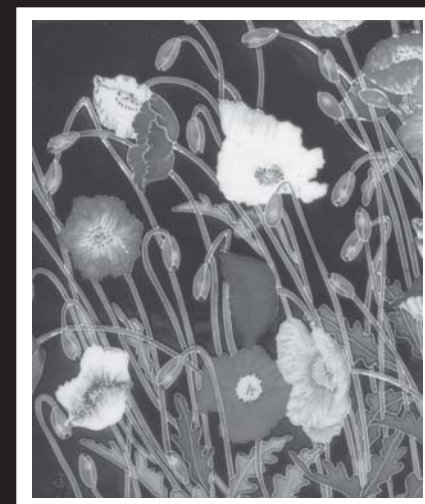

**Booth Sizes:** 10' x 10', 10' x 20'. Corner exposure booths available. All exhibitors must provide his or her own booth structure with cover. Individual tent rentals are available by contacting GHAC.

## HOW TO ENTER

Complete and return festival application (photocopies accepted). Each entry per festival must include separate booth and non refundable application fee. All artists not accepted will have their booth fee returned. No entry will be processed without a completed application accompanied by two checks. Please note: Upon acceptance, there will be no refunds for cancellations after July 1st for Labor Day Festival.

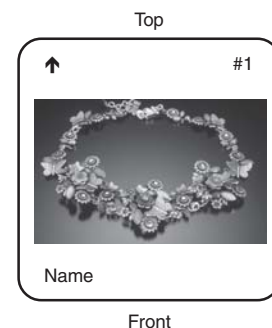

## ENTRY GUIDELINES

Work from molds, kits, patterns, plans, prefabricated forms or other commercial methods is not permitted. All work must be original - no "BUY-SELL" or imports. All artists must personally attend their exhibit and all artists must be present during the entire Artsfest. All artists must be responsible for their own work. Artists must supply display equipment. Work in slides must be representative of the work to be shown at the festival. Only works of art personally created by the artist accepted as an exhibitor at the festival may be displayed or offered for sale. Tapes/CD's of instruments made by the artist may be sold along with the instrument, but not alone. Neither GHAC or the CITY OF HARRISBURG will be held liable for loss or damage to work or property or for personal injury, not shall the artists or any of their representatives be a party to any legal action against any of the above named.

**PHOTOGRAPHY** Photographic prints made from the artist's original negative and which have been processed by that artist, or under his or her direct supervision are included in this category. Photographers are required to disclose both their creative and printing processes.

**SIGNAGE** Each exhibitor is provided with a booth sign showing name, hometown and booth number. This must appear at or above eye level at the front of the exhibitor's display.

**ARTIST SERVICES** Volunteer booth sitters are available during Festival Hours. Festival management will be on-site throughout show hours. Unlimited oversized 4-color artist postcards are available by request.

**SECURITY** All booths must remain set up for the duration of the ARTFESTS at exhibitor's risk. Minimal security will be provided.
